Key Metrics on Pensions in Ireland

Number of pension funds in Ireland: 71,340 of 101,347 in Europe.

70.4%.of pension schemes in Europe are in Ireland

Many of the Irish pension schemes have only 1 member and would not be required to be registered in some other countries.

Irish assets: 147.6bn of 4028.1bn: 3.67%

Other data suggests 160,000 funds – difference appears to be self administered pensions

Just over 120 Registered Administrators

3. Number of pension funds and their assets under management

Most of the assets under management of pension funds that PensionsEurope Member Associations represent are in the Netherlands and in the UK.
