EIOPA: considering the current COVID-19 crisis, more time is given to file some templates, with some control rules being deactivated.

EBA: taxonomy 2.9 starts in March/April as planned; 2 months delay is given for filing COREP/FINREP returns, except for LCR, AML and RESOLUTION which must be filed on normal date.

TFERF (task force on European Reporting Framework): <u>contributions are welcome</u> → to Vincent. See list of ideas on the future needs/standards for regulatory reporting in the attached document.

UK BoE consultation on DATA collection: Bank of England has postponed the limit date for feedback to 20th May (Anne).

BECRIS ANCREDIT (Belgiym): new XSD with info related to COVID-19 public measures (Jean-Marie).

[POC DISCUSSION]

Due to the crisis, nobody had time to work on the POC.

Gina will review the POC's link between FINREP and BIRD, ANACREDI and BIRD during the next weeks.

A call for volunteers will be launched, with a special meeting on 15th April, as agendas have changed for everyone and some new contributors may be available.

The objective of the POC if to show that XBRL may be used by banking & insurance regulators:

- In a more efficient way if the concept use a common dictionary surch as BIRD;
- Also for high volume of granular data
