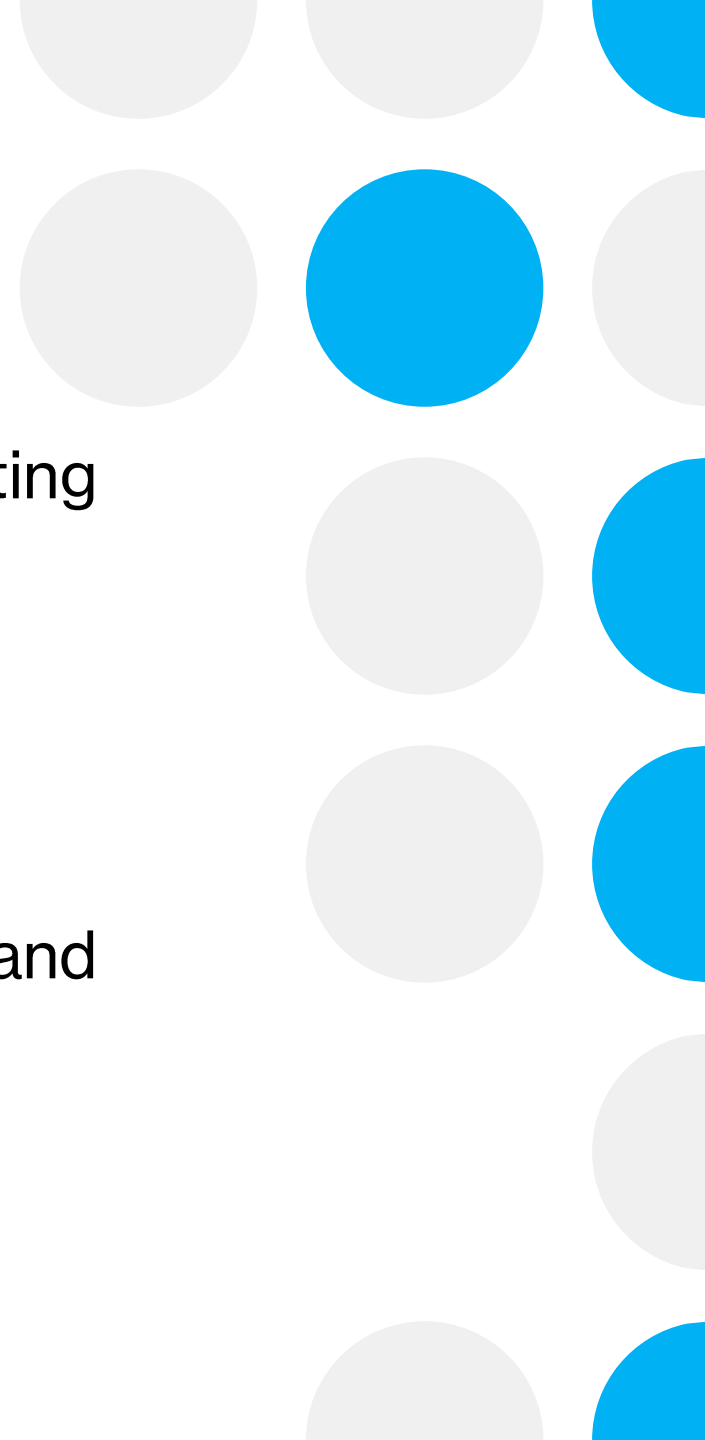

The current situation

MiCA requires standardized digital White paper reporting

Many existing reports are technically compliant but visually very stiff

Generated White papers often look poorly formatted and are therefore more difficult to read
