Through its working groups, annual conferences, and specialized webinars, XBRL Europe provides a vibrant platform for members to exchange knowledge, influence regulatory developments, and build partnerships across industries.

Premium membership is designed for organizations that seek maximum visibility, engagement, and strategic influence. Premium members enjoy enhanced brand presence at events and on the XBRL Europe website, participate in exclusive discussions with the Board, and may host or co-host XBRL Europe events.

Silver membership provides valuable participation rights, access to working groups, and standard visibility on the website and at events, ideal for organizations seeking steady engagement within the XBRL community.

- *Cat 2.3.2 in a country with an XBRL jurisdiction, not member of the jurisdiction*

- *Cat 2.3.3 In a country without an XBRL jurisdiction*
- *Cat 2.3.4 In a country outside of Europe*

Cat 3: Profit Entities registered

- *Cat 3.1 in a country with an XBRL jurisdiction, member of the jurisdiction,*
- *Cat 3.2 in a country with an XBRL jurisdiction, not member of the jurisdiction*
- *Cat 3.3 in a country without a XBRL jurisdiction*
- *Cat 3.4 in a country outside Europe*

Cat 4: Individuals – persons with knowledge and expertise who are assessed to contribute to the objective of XBRL Europe

In Category 3 the members are able to choose between Premium and Silver membership with benefits attached and adapted fees as explained further.
